

ADDITIONAL CONDITIONS OF MEMBERSHIP

Each member **must** complete one of the following during the membership year in order to maintain membership. Failure to do so will disqualify member from renewal.

1. Volunteer at 2 events. During the event, member must “sign in” in order to have volunteer time counted. Failure to do so may require member to perform another volunteer day.
2. Take on a project or serve as a volunteer coordinator. This will be at the discretion of the Board of Directors to approve.
3. Have a waiver, approved by the Board of Directors due to age or disability.
4. Pay an additional \$50 to “opt out” of volunteer service. This must be paid at the beginning of the membership year OR at the end if you as the member are unable to fulfill your volunteer obligations.

At the discretion of the Board of directors, volunteer obligations can be suspended if during the calendar year events are limited due to unforeseen circumstances.

WAIVER AND RELEASE AGREEMENT

Please read carefully before signing

This is a release of liability and waiver of certain legal rights

In consideration for me being permitted to participate in the activities of the North American Rod and Gun Club, I agree to the following Waver and Release:

I acknowledge that shooting in all forms and hunting have inherent risks, hazards and dangers for anyone that cannot be eliminated, particularly in an outdoor environment. I UNDERSTAND THAT THESE RISKS, HAZARDS AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others who have firearms in their possession;
2. The risk of injury from ammunition and shot from other guns, including, but not limited to paint-ball guns;
3. Walking in rugged country, including encounters with wildlife, animals and insects;
4. Inclement weather conditions;
5. The risk of injury from riding on an all-terrain vehicle (ATV) or any vehicle used off the paved road.
6. The risk of injury for the use of tree stands.
7. The use of alcohol, or drugs, prescription or otherwise, that may impair mental ability, will NOT be permitted before or during any shooting activities.

I understand the risks, hazards and dangers as described above and have had the opportunity to discuss them with Club Officers, and Committee Chairmen. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe that I have the good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in these activities is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF THE NORTH AMERICAN ROD AND GUN CLUB WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS AND DANGERS INVOLVED, AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and suborns, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS, the North American Rod and Gun Club, its directors, officers, agents, employees and volunteers from and against all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to, arise out of, or are in any way connected with, my participation in these activities including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or not foreseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or use of these services, animals or equipment, whether such damage, loss, injury, paralysis or death results from negligence of the North American Rod and Gun Club, or from some other cause. I, for myself, my heirs my successors, executors and suborns, further agree not to sue the North American Rod and Gun Club, as a result of any injury, paralysis or death suffered in connection with my use and participation in the activities of shooting, hunting and all other activities for sport or leisure at the club or its premises.
